When you sign this form, it means you understand the following:

<ul style="list-style-type: none"><li>• MyCare Ohio plans have a contract with the federal government and with Ohio.</li><li>• The health services you get with your new plan may be different than the services you had before.</li><li>• I must keep Part A, Part B, and Ohio Medicaid.</li><li>• I can be in only one Medicare plan at a time.</li><li>• By enrolling in MyCare Ohio, I'll end my enrollment in another Medicare health or prescription drug plan.</li><li>• I must tell Medicare and Ohio Medicaid about any prescription drug coverage that I have or may get in the future.</li><li>• If I move, I need to tell my county caseworker.</li><li>• As a member of MyCare Ohio, I have the right to appeal if I don't agree with my plan's decisions about payment or services.</li><li>• I understand that my MyCare Ohio plan's member handbook includes the rules I must follow.</li><li>• The MyCare Ohio doesn't usually cover people while they're out of the state, but there may be some limited coverage across the Ohio state border.</li><li>• On the date my coverage begins, I must get my health care from my plans providers, except for emergency or urgently needed care.</li><li>• My plan will cover my health care with their network providers and other providers as outlined in their member handbook.</li></ul>	<ul style="list-style-type: none"><li>• If I need to see a provider or other provider who isn't in in my plan's network, I may need prior authorization or I may have to pay out-of-pocket for the services I get.</li><li>• By enrolling in a MyCare Ohio plan, I know that my plan may share my information with Medicare and Ohio Medicaid and other plans as necessary for treatment, payment, and health care operations.</li><li>• I understand that prescription drugs are covered, but not always the same ones I'm already taking. I understand I'll have access to my current drugs for at least 30 days, until I can switch to different drug.</li><li>• I know that my MyCare Ohio plan may share my information, including my prescription drug event data, with Medicare and Ohio Medicaid. They may release it for research and other purposes, as allowed by federal statutes and regulations.</li><li>• The information on this form is correct to the best of my knowledge. I understand that if I intentionally provide false information on this form, I'll be disenrolled from MyCare Ohio.</li><li>• My signature (or my authorized representative's signature) on this form means that I've read and understood this form. If an authorized representative signs, the person's signature means that he or she is authorized under State law to complete this enrollment, and documentation of this authority is available upon request from Medicare and/or Ohio Medicaid.</li></ul>
